# NATIONAL COMMITTEE ON VIETNAMESE SCOUTING in USA

## GUIDELINES

1. NAME: National Committee on Vietnamese Scouting in USA

## 2. PURPOSE:

- To promote and support Vietnamese Scouting within Boy Scouts of America and Girl Scouts of USA.
- To coordinate Vietnamese Scouting activities within United States.
- To preserve and promote Vietnamese culture, language, tradition and history.

#### 3. OFFICER:

- National Committee on Vietnamese Scouting in USA consist of three (3) representatives from 3 region: Western Region, Central Region and Eastern Region.
- National Committee on Vietnamese Scouting in USA consist of following officers:
  - \* Chairman
  - \* Vice-Chairman / Publication & Communication
  - \* Vice-Chairman / Secretary & Treasure

## 4. ELECTION:

- Each unit that registered with the BSA or GSUSA have one vote to elect their regional representative for their own region. If unit is absented, they can send in absentee ballot or proxy.
- Three Regional Representatives after been elected, then intern selected between themselves a Chairman and 2 vice-chairman.

## 5. TERM OF OFFICE:

- Term of National Committee on Vietnamese Scouting in USA officers are three (3) years from the date elected.
- After each term, the officer of previous term can re-run for office.

#### 6. FUNCTION:

- Organize the meeting and election of the National Committee on Vietnamese Scouting in USA Officers.
- Appoint all subordinates officers and all special events chairmen.
- National Committee on Vietnamese Scouting in USA is the legitimate official spokesman for all the unit that belong to The National Committee on Vietnamese Scouting in USA.

### 7. GUIDELINE:

- To follow the Bylaws, Policy and Guidelines of the Boy Scouts of America and Girl Scouts of USA.
- To respect the policy and guidelines of the International Central Committee of Vietnamese Scouting.

## 8. ACTIVITIES:

- National Committee on Vietnamese Scouting in USA will meet quarterly.
- National Committee and all officers will meet once a year.
- National Committee have the right to call for a special meeting when necessary.
- Publish National Committee Newsletter.

#### 9. FINANCE:

- Each member unit will contribute an annual due of \$10.00 (Ten Dollars) per unit.
- The fund will be use for the necessary expense of the National Committee.
- Each year, the treasurer will have a finance report and will be published in the National Committee Newsletter, and be reviewed and approved by the National Committee at the annual meeting.

## 10. AMENDMENT:

- Any changes in this National Committee on Vietnamese Scouting in USA Guidelines will need to have two-third of the votes of its members.

The above Guidelines were agreed and approved by majority of the Leader were present at The National Committee on Vietnamese Scouting Conference held on September 01, 1991.
